3. Confirmation of section host schools (see the chart below)

- a. Section host school policy: Section schools are encouraged to develop their own rotation of the True Team Section Meet from those schools who are interested in hosting the meet. However, if a rotation cannot be agreed upon the True Team Chairman will intercede and determine a rotation. No school may host a section meet until they have first participated in the MSHSSCA True Team.

4. Section Meet Issues: Host Schools should personally contact all the teams in their section and encourage them to attend the True Team Section Meet.

- a. Awards: the awards will once again be ordered from Hasty Awards
- b. The following will be added to the True Team Charter:

At True Team meets divers who are performing a six-dive list are to follow the "MSHSL Voluntary Dive List" required for the date of the meet as posted at MSHSL.ORG

Section meets who run at a negative fund balance due to not all section teams participating may request that the True Team committee cover a portion or all of the cost of awards. The section meet income and expenses are to be submitted with the request.

- c. Note: Boys Section 3A has decided to hold their True Team Section Meet one week early on 1/12/2013. The rationale for the date change was so that the meet could be

held in the same pool as the MSHSL Section Meet and there was a conflict on the original date.

- d. A motion was made by Chris Aarseth and seconded by Jen Marshall to add a statement to the True Team Charter the window of time the week prior to the True Team State Meet when the True Team Section Meets are to be held. Motion passed.

Section True Team State Meets are to be held during the window of time the previous Wednesday – Saturday the prior week before the True Team State Meet. For example: If the True Team State Meet has been scheduled for a date between Wednesday, October 17, and Saturday, October 20, the True Team Section meets shall be held during the following window of time: Wednesday, October 10, and Saturday, October 13. Sections who wish to hold their meet at a time outside the above described window of time may do so by mutual agreement of all schools in the section who participate in the True Team and the approval of the True Team Committee.

5. State Meet Issues:

- a. Only media with credentials will be allowed on deck per meet manager's approval
- b. Note: True Team State Meet Manager, Chris Aarseth will add media requirements to the True Team State Meet Information.
- c. The following will be added to the True Team Charter:

At True Team meets divers who are performing a six-dive list are to follow the "MSHSL Voluntary Dive List" required for the date of the meet as posted at MSHSL.ORG

- d. State True Team T-shirt sales: Due to construction there will be no space for Fine Designs to set up and sell T-Shirts at the True Team State Meets. True Team Chairman, Rick Ringeisen is working with the University of Minnesota and Fine Designs to work out an alternative plan to allow T-shirt sales to take place at this coming year's True Team State Meets.

6. MSHSCA True Team Scholarships – True Team Scholarship Chairman Chris Aarseth

- b. Scholarships have been named in honor of "Trapper Jim" (AKA: Jim Marshall) the original True Team sponsor, and Art Downey the dean of high school swimming in Minnesota.

- b. Bob Crunstedt the Executive Director of Minnesota Swimming Incorporated attended the True Team Committee Meeting and committed Minnesota Swimming Incorporated as a True Team Swimming & Diving sponsor for the 2012-2013 school year.
