#### 4. True Team Finances:

a. The breakdown for the net gain to the coaches association from the True Team is as follows:

i. 2009-2010: \$6,320.00 ii. 2010-2011: \$7,559.81 iii. 2011-2012: \$6,069.48 iv. 2012-2013: \$9,720.94

v. 2013-2014: \$9,283.25

vi. Total: \$38,953.48

- b. The above earned money has been used to subsidize a portion of the price of awards to the section meet host teams, to assist in the funding of the coaches association annual scholarships, and to increase the coaches association's general fund.
- 5. Section & State Meet Issues: Host Schools should personally contact all the teams in their section and encourage them to attend the True Team Section Meet.
  - a. State Meet Scheduling Issues at the University of Minnesota (explained above under #2)
  - b. Section Meet Entry Fees will increase from \$95.00 to \$105.00 starting with the 2014-2015 school year. The motion was made by Brian Luke, and seconded by Justin Haycraft. Discussion: the increase in price will increase profit for the section meet host teams and still allow the True team be an affordable invitational meet to attend. The motion carried unanimously.

- c. Section Meet Awards
  - i. The current price for the True Team Awards from Trophies Plus is \$7,861.50 / 34 meets = \$231.22 per meet.
  - ii. Last year we invoiced the section meet host \$190.00 for awards.
  - iii. The section meet host will be invoiced \$170.00 for awards starting with the 2014-2015 school year. This is a \$20.00 reduction from previous years. The motion was made by Todd Walsh, and seconded by Jeff Mace. Discussion: The True Team has been successful in generating consistent income from sponsors and it is now possible to pass along additional saving to the section meet host team to increase their profit from hosting True Team Section Meets. The motion passed unanimously.
  - iv. Should the amount invoiced remain the same, be increased, or decreased?
  - v. Should we impose late fee for the late payment of invoices?
  - vi. A late fine of \$30.00 is going to be added to schools invoices after 60 days who have not paid their True Teams Section awards invoices and True Team State Meet entry fees. The motion was made by Justin Haycraft, and seconded by Dale Magnuson. Discussion: There needs to be a policy to improve the payment of invoices on time. Motion carried unanimously.

- 7. MSHSCA True Team Scholarships Chris Aarseth our scholarship chairman reported that there has been a steady increase in the number of applicants for the scholarships each year. There were 26 applications in 2013-2014, up form 12 the first year of the scholarship program. Chris is going to provide Todd Walsh our web master a list of the student/athletes who have been awarded scholarships to be posted on our association web page. The scholarship application is also going to be amended to request that scholarship award winners write a thank you to be posted on the association web page.

#### 8. New Business-

- a. True Team Web Site: The True Team Web site is currently being hosted by the Lakeville North High School Swimming & Diving Boosters and the web master is Wendy Wulff. This relationship will continue for the 2014-2015 school year
- b. Note: The Class A Boys Diving proposal to expand the number of divers who advance to the state meet from three to four athletes was passed this spring by the MSHSL.
- c. Rick Ringeisen announced that it is time for him to consider an exit strategy from the True Team Chairman position. Rick has served as the True Team Chairman sine the inception of the committee (2001-2002) three years prior to the launch of the True Team (2004-2005) and plans to continue to serve as the True Team Chairman through the 2014-2015 school years. It is now time for another coach with a strong passion for the True Team to step up and serve.
- d. Chris Aarseth thanked Rick for his passion, dedication and services to the coaches association in the creation of the True Team. Chris also noted the profound positive impact True Team has made on the sport of Swimming & Diving. Several other members of the committee echoed Chris's sentiments.
